## Profiling & ID document authentication

### Theory

The Keesing ID e-Course starts by introducing the ins and outs of ID documents. Participants will subsequently acquire the knowledge needed to inspect ID documents.

### Skills

This part of the course is structured around a useful 3-stage process: look, feel and tilt. The process allows participants to inspect the security features found in ID documents. In turn, this enables them to establish the authenticity of the document (and thus detect counterfeits).

### Profiling & lookalike fraud

The profiling module shows participants how to recognise and prevent lookalike fraud - an increasingly common yet often overlooked crime that is difficult to detect. The Keesing ID e-Course will also show participants how to spot lookalike fraud.

### Final exam

Each module ends with a test, allowing participants to assess whether they are sufficiently prepared for the final exam. Should they pass the exam, they will receive a certificate to confirm they have the basic skills needed to inspect an ID document.
