Know-Your-Player Identity Verification Best Practices for (Online) Gambling Operators

Through AML regulations and KYC requirements, gambling operators are required to verify the identity of their customers before they are permitted to perform deposits and/or bets.

It is the operator's responsibility to ensure that the identity verification procedure is fit-for-purpose and being implemented effectively. Operators lacking effective verification tools face a real challenge in meeting compliance requirements.

In addition, providing a streamlined onboarding journey to players is key in the highly competitive online gaming industry. For the operator, the process needs to be seamless and flexible, allowing adequate deployment of updates and new features. To support organizational growth, scalability in handling more customers is vital.

How can gambling operators protect their businesses and players against fraud and achieve regulatory compliance, while simultaneously ensuring a smooth onboarding process?

There are generally three levels of performing customer identity verifications. Which one is applied depends on the (daily) volume of customers to be handled, the resources the operator is willing to allocate for this and the (expected) organisational growth.



Startups and SMBs
